- ♪ **This competition is open to all music students ages 12 through 18** who reside in Connecticut and/or study with teachers living in CT.
- ♪ **Application deadline: (postmarked): January 20, 2022.**
- ♪ **Audition time preferences will be honored in the order of the receipt of the application.**
- ♪ **Application Fee:** \$50.00 (non-refundable) Checks should be made out to "American Chamber Orchestra" and mailed to Nanette Jordan, ACO Concerto Competition, 33 ½ A Plymouth Avenue, Norwalk, CT 06851.
- ♪ **Vaccination Requirements:** Please email proof of vaccination for the student auditioning and the accompanist. ([nanmj618@gmail.com](mailto:nanmj618@gmail.com))  
**Masks are required while inside the building.**
- ♪ **Repertoire:** Contestant may play any movement of any major Baroque, Classical, or Romantic Concerto (nothing newer than 1920). Concerti by contemporary composers will not be eligible. The music must be memorized and a copy of the music brought to the judges. Choice of music is subject to approval by Chris Hisey, American Chamber Orchestra Music Director.
- ♪ **Accompanist:** Each contestant is required to bring his/her own accompanist for both the auditions and the recital events.
- ♪ **The Competition** will be on Friday, Feb. 25<sup>th</sup> and Saturday Feb. 26<sup>th</sup> from 6:30-9:30pm at Faust Harrison Pianos, 322 Black Rock Turnpike, Fairfield, CT. The preliminary performances are private.
- ♪ **Finalists** will be notified by email no later than **9:00pm Saturday, February 26.<sup>th</sup>** If you do not receive an email by that time, please contact Mrs. Jordan at [nanmj618@gmail.com](mailto:nanmj618@gmail.com). Please put this address in your contact list so that it goes in your "Inbox."

- ♪ **Finalists Recital:** Finalists will be expected to perform in the finalist recital on the morning of **Sunday, February 27th, 2020, at 9:30 am** at Faust Harrison Pianos, 322 Black Rock Turnpike, Fairfield, CT, with your accompanist. **The winners will be announced at the end of the recital.** *(Please note that family members and friends are invited to attend this recital with proof of vaccination, or a negative PCR test within 72 hours. Masks are required for this recital.)*
- ♪ **Winners:** Three winners will be chosen at the end of the Finalists Recital. The winners will get to perform with the American Chamber Orchestra and will receive a cash prize.
- ♪ **Judges:** Decisions of the judges are final, and their comments will be emailed to participants.
- ♪ **Rehearsals: Winners must** attend all three rehearsals preceding the concert: **Sunday, June 5<sup>th</sup> time TBA; Thursday, June 9<sup>th</sup> and Friday, June 10<sup>th</sup> at 7:30 pm.**
- ♪ **Concert: Winners must** perform at the American Chamber Orchestra's Spring Concert on **Saturday, June 11<sup>th</sup>.**
